- Decorations may be put up at the start of your rental. No pinatas, confetti, silly string, or water balloons allowed.
- Your party will be allowed to enter the facility no earlier than 6:30pm and will depart at rental time stated above.
- The Parks Department reserves the right to determine who may be permitted to rent the Clarksville Cove Family Aquatic Center, based upon the appropriate use of this family facility.
